MORRISTOWN MUNICIPAL ID APPLICATION

As a Town of Morristown Municipal Identification cardholder, I understand that:

- The Morristown Municipal ID Card ("MMID") is issued solely to residents of the Town of Morristown, NJ and is non-transferable.
- The MMID is issued to assist in the identification of the valid cardholder for the purposes of obtaining services from the Town of Morristown.
- MMID card is valid for a term of 2 years from date of issuance.
- Altering or intentionally damaging the MMID, using another person's card, or allowing your MMID to be used by another person may result in confiscation of the card and violation of N.J.S.A. 2C: 28-7.
- Cardholder must notify the Town of Morristown immediately if a card is lost or stolen.
- The cardholder is responsible for paying any replacement fee when a MMID is lost, stolen, confiscated, or intentionally damaged, or when any information is changed at cardholder's request.

Relocation out of the Town of Morristown invalidates the card, which shall be returned to the Town for destruction. Any use in violation shall forfeit any application of the MMID.

FEES

All applicants must meet the following criteria to apply for the Morristown Municipal ID Card:

- New Application: (Adult) \$15
- - (Senior/Child/Disabled/Veteran) \$ 7
- Information Change \$7

6 POINTS OF PROOF ARE REQUIRED: 4 IDENTIFICATION + 2 RESIDENCY POINTS

All documents must be original or certified copies, and have the required state and/or municipal seals.

Proof of Identity: 4 Points Required

3-Point Documents

- Consular ID with photograph
- Visa or U.S. Work Permit (current)
- National identification card (Must have photo, name, address, date of birth and expiration date)
- U.S. Birth Certificate
- U.S. Permanent Resident (Green Card)
- U.S. Citizenship and Naturalization Certificate
- U.S. Federal Government or Tribal-issued photo ID
- State Veterans ID with photo
- Temporary Protected Status (TPS) card with photo
- U.S. Military ID card
- U.S. Passport

2-Point Documents

- Foreign Passport
- Foreign driver's license
- Prisoner ID card
- Face Sheet (formerly incarcerated released form)
- Foreign military identification card with photo
- Foreign Birth Certificate
- NJ Auto Registration - Valid

1-Point Documents

- ITIN card (must be accompanied by an ID with a photograph)
- Written verification issued by a social services agency or homeless shelter. Must be notarized.
- Social Security card
- Electronic Benefit Transfer (EBT) card
- High school or college diploma
- Voter registration card
- Unemployment Photo ID Card

Proof of Identity / Residency

4-Point Documents

- U.S State Driver's License or Learner's Permit Photo ID
- U.S State Identification Card

Proof of Residency: 2 Points Required

2-Point Documents

- Utility bill with name and address
- Notarized residential lease
- Automobile insurance card

1-Point Documents

- Proof of a minor enrolled in Morristown public or private school
- Insurance bill other than automobile
- Bank statement
- Employment pay stub (Dated within 60 days)
- Local property tax statement
- Federal or State income tax or refund statement
